Dear Creditors

Kingate Global Fund, Ltd. - In Liquidation

I refer to my previous letter to the creditors of Kingate Global Fund Limited (the "Fund"), dated 9 June 2009, in which I indicated that it was Joint Liquidators' intention to hold meetings of creditors and investors within 21 days.

I now attach a formal notice of the meeting of creditors, which will be held at the offices of Zolfo Cooper (Europe) Limited, 10 Fleet Place, London, United Kingdom, on Wednesday 24 June 2009 at 12:00pm (British Summer Time). The Joint Liquidators have decided to hold the meeting in London, as the majority of the Fund's reported creditors are based in a number of countries in Western Europe and therefore, London was considered by the Joint Liquidators to be the most convenient location. Please ensure that you read the attached notice carefully.

The Joint Liquidators apologise for convening the meeting at short notice. However, there are a number of very important decisions which must be taken by them prior to claims bar date in the liquidation of Bernard L. Madoff Investment Securities, LLC on 2 July 2009, upon which they would like to seek the views of the creditors and investors.



As set out in the notice, creditors may vote in person at the meeting or may appoint another person, as their proxy to attend and vote in their place. Any creditor wishing to appoint a proxy to attend on their behalf must complete a Form of Proxy, which will also need to be returned to the Joint Liquidators by no later than 12.00 noon (British Summer Time) on Tuesday 23 June 2009. Forms of Proxy will be sent out to creditors, on or about 17 June 2009.

The Joint Liquidators are in the process of preparing their first report to creditors and investors and an agenda for the meeting. These will be circulated to the creditors, together with a Form of Proxy, on or about 17 June 2009.


The purpose of the meeting is for the Joint Liquidators of the Fund to provide an update to Creditors on the progress of the liquidation and to consider a formal resolution to establish a Creditors' Committee. The majority required to pass a formal resolution at the meeting is not less than 50% by value of the claims of those attending in person or by proxy.

The Joint Liquidators also intend to take soundings from the Creditors at the meeting in relation to certain fundamental matters arising in the liquidation of the Fund and in particular, the proceedings which have been filed against the Fund in the United States Bankruptcy Court for the Southern District of New York by Mr. Irving H. Picard, Trustee for the liquidation of the business of Bernard L. Madoff Securities LLC.

Creditors will be asked to express their wishes by way of an informal vote on certain matters. These matters will be set out in detail in the Joint Liquidators First Report to Creditors and Investors ("Report"), which will be circulated to Creditors on or about Wednesday 17 June 2009.

Creditors should lodge particulars of their claims for voting purposes on the attached Claim Form at the offices of Zolfo Cooper (BVI) Limited, Palm Grove House, 2nd Floor, PO Box 4571, Road Town, Tortola, British Virgin Islands VG1110, by no later than 12.00 noon on Tuesday 23 June 2009.
